Resolution Approving the FYE 6/30/26 Budget of the Resident Council of the Princeton Housing Authority

WHEREAS, the Princeton Housing Authority (including any successors or assigns, the "Housing Authority"), was duly created as an agency and instrumentality of the municipality of the State (the "Local Unit") in which such Housing Authority is located, and has been continued as a housing authority pursuant to and in accordance with the provisions of the Local Redevelopment and Housing Law, constituting Chapter 79 of the Laws of 1992 of the State, and the acts amendatory thereof and supplemental thereto (*N.J.S.A.* 40A:12A-1 et seq.) (the "Local Housing Law");

WHEREAS, the Resident Council of Princeton Housing Authority (RCPHA) has created and approved its annual budget for the FYE 6/30/2026; and

WHEREAS, the RCPHA is presenting its proposed FYE 6/30/2026 budget for approval and funding by the Princeton Housing Authority.

NOW, THEREFORE, BE IT RESOLVED that the Board of Commissioners of the Princeton Housing Authority does authorize and approve the Budget of the Resident Council of the Princeton Housing Authority and further authorizes the release of funds for the approved RCPHA FYE 6/30/26 Budget.
